Motion by Trustee Brazill/second by Trustee Sharp to approve the Minutes as presented. Motion carried unanimously.

CORRESPONDENCE:

Letter dated July 10, 2008 addressed to Supervisor Jaeger from Bob Wilson. Bob noted his service to the Senior Services Committee during the past six years. He had decided not to seek reappointment to the committee. Letter dated July 14, 2008 addressed to Supervisor Jaeger from Carole Woods. Carole asked to be reappointed to the committee. She noted her experience and eagerness to continue to serve.

Letter dated June 17, 2008 addressed to Geneva Township Board of Trustees was received from Greg Mills. Greg wrote that he would not seek reappointment to the Senior Services Committee. He hoped that the center would become a vital part of the community.

Clarke Mosquito Control Update was received for June, 2008.

Letter dated July 1, 2008 was received from Amy Baudouin, Flu Shot Coordinator for the VNA. Geneva Township will be a flu shot clinic site on Monday, October 13, 2008 from 9:00a.m. to 12:00 p.m.

TOWNSHIP BUSINESS:

RTA PHOTO SERVICE

Supervisor Jaeger stated that the township had been providing photos for the RTA free ride card. The RTA website has indicated that the photos are provided free of charge at Geneva Township. Individuals from other areas have been coming for the free photos. Supervisor Jaeger asked the trustees to consider assessing a charge for those who do not live in Geneva Township. Trustee Brazill thought providing the photos was a good service, but agreed there should be a charge for those who do not live in the township. Motion by Trustee LaCure/second by Trustee Wissing to charge \$6.00 per photo ID for those who do not live in Geneva Township.

There was continued discussion regarding alternatives and bases for costs. Sheri McMurray, Administrative Assistant to Supervisor Jaeger said that the RTA website shows "photo provided," suggesting it is free. She thought the site should be changed to say "photo service."

Trustee LaCure moved to amend the motion to change the website to say photo provided with a \$5.00 charge. Second by Trustee Wissing.

SENIOR SERVICES COMMITTEE:

There was no meeting as there was no quorum. SENIOR SERVICES DIRECTOR:

Gayle Kennedy highlighted some of the new programs: exercise classes, genealogy classes, and some new games. She noted that there were 95 people who attended the last free lunch. She said that healthy snacks are provided at the center. There will be a miniature golf game on August 12th.
