AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE COUNTY, ILLINOIS FOR THE TAX YEAR 2010 TO BE COLLECTED IN 2011

BE IT ORDAINED BY THE TRUSTEES OF THE TOWNSHIP OF GENEVA, KANE COUNTY, ILLINOIS, as follows:

Section One: The Highway Commissioner of the Geneva Township Road District on October 21, 2010 does hereby determine and declare that the sum of TWO HUNDRED EIGHTY-SIX THOUSAND TWO HUNDRED FORTY SIX DOLLARS (\$286,246.00) is hereby levied upon all property subject to taxation within Geneva Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Geneva Township Road District as required by statute or voted by the people in accordance with the law, for such purposes As:

- A. Road Fund
- B. Permanent Road Fund
- C. Equipment and Buildings
- D. Illinois Municipal Retirement (IMRF)
- E. Liability Insurance
- F. Social Security

Section Two: That the amount levied for each object and purpose shall be as follows:
