AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE COUNTY, ILLINOIS FOR THE TAX YEAR 2016 TO BE COLLECTED IN 2017
