AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE COUNTY, ILLINOIS FOR THE TAX YEAR 2017 TO BE COLLECTED IN 2018

BE IT ORDAINED BY THE TRUSTEES OF THE TOWNSHIP OF GENEVA, KANE COUNTY, ILLINOIS, as follows:
