# ORDINANCE NO. \3 -18

AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE COUNTY, ILLINOIS FOR THE TAX YEAR 2018 TO BE COLLECTED IN 2019

BE IT ORDAINED BY THE TRUSTEES OF THE TOWNSHIP OF GENEVA, KANE COUNTY, ILLINOIS, as follows:

Section One: The Highway Commissioner of the Geneva Township Road District on December 20, 2018 does hereby determine and declare that the sum of THREE HUNDRED TWENTY ONE THOUSAND THREE HUNDRED SIXTY DOLLARS (\$321,360.00) is hereby levied upon all property subject to taxation within Geneva Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Geneva Township Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- A. Road Fund
- B. Permanent Road Fund
- C. Equipment and Buildings
- D. Illinois Municipal Retirement Fund (IMRF)
- E. Liability Insurance
- F. Social Security

Section Two: That the amount levied for each object and purpose shall be as follows:
